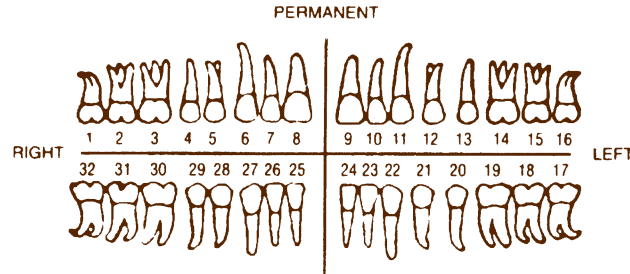

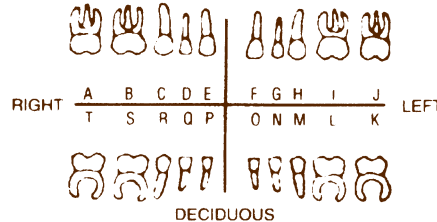

If you are having general anesthesia or sedation:

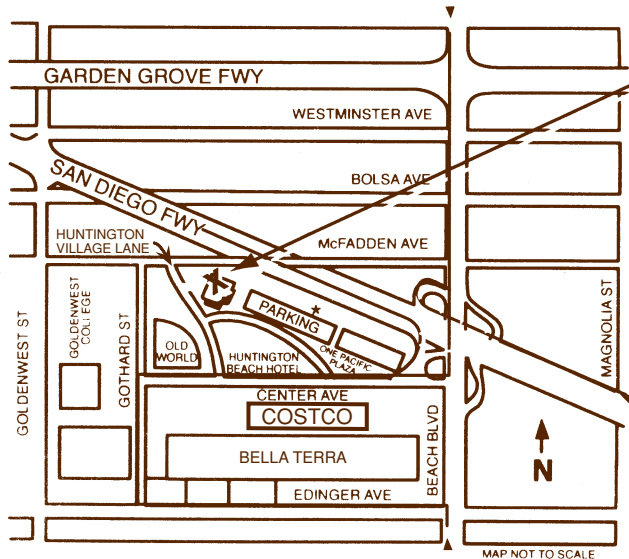
**NO FOOD or LIQUID** for 8 hours before your appointment. **DO NOT** plan to drive home.

Please wear short sleeves and loose-legged pants.

If you are a **MINOR** (under 18 years) you must be accompanied by a parent or legal guardian.

**HUNTINGTON BEACH OFFICE - 7677 Center Avenue, Suite 206**

- **From north of Huntington Beach** - Take Beach Blvd. exit south off San Diego Fwy. **Stay in right lane** and follow signs to Center Avenue. Turn right onto Huntington Village Lane and make a right into second driveway.
- **From south of Huntington Beach** - Take Beach Blvd. exit south off San Diego Fwy. Pass under freeway and immediately turn right on Center Avenue. Turn right onto Huntington Village Lane and make a right into second driveway.
- **From Beach Blvd, south of 405 Fwy** - Turn left on Edinger, right on Gothard, right on Center (cross RR tracks). Then turn left onto Huntington Village Lane and make a right into second driveway.
- **From Beach Blvd, north of 405 Fwy** - Go south under freeway. Turn immediately right on Center Avenue, pass beyond the One Pacific Plaza entrance. Turn right onto Huntington Village Lane and make a right into second driveway.
